Carol Olson read the following to the Board of Directors:

"Is any member aware of any conflict of interest, that is, of a personal interest or direct or indirect pecuniary interest, in any matter being considered by this meeting which should now be reported of disclosed or addressed under the Midwestern Swimming Conflict of Interest Policy?"

If a Board member determines there to be a conflict of interest at any point during the course of the meeting when a specific subject is being discussed and/or action is being taken, a declaration of a conflict of interest should be made at that time.

#### **MINUTES**

The minutes of the previous meeting, held on 12 November 2019, were reviewed. Betty Kooy asked that the record reflect the fact that Emma McEntarffer was present at the last meeting. The minutes will be changed to reflect Emma's presence. A motion to approve the November minutes was made by John Tysdal. Second by Steve Marchitelli. A vote was conducted with all in favor. The November minutes are APPROVED.

#### **CONSENT AGENDA**

The Consent Agenda was introduced, including reports by the Executive Secretary, Registration, and Operational Risk. Bruce Schomburg inquired about the name and format of the meets formally known as Last Chance Meets. Betty says there is no format change. The official name of the meet will be Championship Challenge and 8 & Under Area Final. Area 1 will be hosted by CBSC, in Council Bluffs. Area 2 will be hosted by HLA, in Lincoln. Bruce also asked about USA Swimming Observation of High School Meets. MWS does not observe meets in Iowa, only in Nebraska. Steve Marchitelli reminded Bruce that Iowa Meets would fall under the Iowa Swimming jurisdiction. Motion to review and approve the Consent Agenda by Brinker Harding. Second by Jimmy Parmenter. A vote to approve the updated Consent Agenda was had with all in favor. The Consent Agenda is APPROVED.

### **CURRENT BUSINESS**

Safe Sport Winter Pool Party – Carol shared notes from Aiden about the party. 120 people attended the party. Not many coaches attended. A scavenger hunt was one of the activities. Safe Sport had a table at the event. 18 sponsors contributed to the event, with the majority of the funds coming from McGrew Trucking.

Governance Committee – Three committee members, Betsy Purcell, Toby Rees, and Thor Larson, met recently at the MAC Meet. Nomination forms will be posted soon, according to Betty Kooy. Nominations are encouraged for positions that will be open in September 2020. Please forward nominations to any of the committee members.

Finance Committee – Jason Hiley, Thor Larson, Carol Olson, and Betsy Purcell, will each do research on sample policies to help guide the creation of a policy for MW Swimming. The committee hopes to have some information at the next meet.

Financial Report – Jason Hiley gave an update on the current MW Swimming financial status. Reports have been updated through the end of 2019, with all income and expenses in the books. The Balance Sheet shows a decline of about \$9K from 2018. The Profit/Loss statement shows a loss of about \$18.5K. Budget vs Actual reporting shows splash fees have decreased by about \$4K. According to Scot, membership has declined by approximately 130 athletes. Both of these reflect in the income. The 2020 Budget was voted on before 2019 data was in the books. Jason is not concerned yet, but if declines continue, changes to the budget will need to be considered. The Balance sheet shows \$270K in assets, the same as 2015. A trend is not yet observable, but Jason will be looking for trends. MW Swimming had budgeted a \$21K loss, but the actual loss was only \$18K. Athlete reimbursements were higher in 2019. Jason claims budgeting is difficult, noting that some items we don't budget for will arise, and other budgeted items never occur. Jason reiterated he is not concerned yet, but is on the lookout for new trends in our finances. Betty notes that there were late deposits for splash fees. Athlete reimbursements for National Meets and Futures Meets are the most accessed. Athlete reimbursement to MWS Athletes at Olympic Trials this year will be up to\$1000. Betty suspects there will be a decline in attendance at the Futures Meet in Fargo.

### **NEW BUSINESS/DISCUSSIONS**

Steve Marchitelli reminds those on the call that athletes of the age of 18 need to be compliant with MAAPP, Minor Athlete Abuse Prevention Policy.

Steve Marchitelli also inquired about the need to purchase new radios for Officials to use for meets. Betty told Steve to go ahead and purchase the required radios, and send her the bill for reimbursement.

Betty Kooy reminds those on the meeting call that athlete numbers are down, splash fees are down, and meets are less attended than previous years. With Flex Membership, athletes are only allowed to compete in 2 meets. In previous Olympic years, MW Swimming has seen a bump in new athletes.

Bruce Schomburg voiced his opinion about elevated meet entry fees. He feels a \$27 fee for a novice swimmer entering 2 events at a meet, is not appealing to a novice swimmer.

Carol reminds the group that participation in youth sports is declining nationwide.

Jay Thiltgen spoke about the difficulties of a new swimmer who joins the sport later that most swimmers. This is a difficult sport to join at a later age. He pondered dividing athletes into groups by abilities. Bruce Schomburg reminds the group that B- Meets are intended to serve the slower, less competitive, and newer athletes.

### UNREGISTERED ATHLETES ONLY

### **CURRENT PROCEDURE**

- 1. Perform pre-meet recon
- 2. Notify club host and entering club of outliers
- 3. Continue to perform recons based on number of outliers and updated athlete registrations
- 4. Final pre-meet recon performed 1-2 days before competition
- 5. Perform post-meet recon
- 6. Distribute fine notices to affected club(s), which is \$100.00 for each unregistered athlete.

To date, there have been no UN athletes affected.

- 7. Times achieved for unregistered athletes are entered into SWIMS.
- No action can be taken against an LSC outside of MW should one of their unregistered athletes actually compete

### PURPOSE OF THIS PROPOSAL:

MW sanctioned competition with unregistered athletes (UA) jeopardizes liability coverage for all attendees. All UA appearing on the first pre-meet recon should have been registered before entry, but regular roster syncing with SWIMS is not performed. Several clubs are notorious for a large number of UA notification, some to the point of routinely being double digits. Rather than the typical notification(s) sent multiple times to clubs, last minute registration still occurs either the day before or day of competition, many times after the final pre-meet recon. The meet host must then be the final checkpoint with simple options to either verify membership or deny access. The goal is to eliminate UA in advance of the initial pre-meet recon with a stern punitive action at the post-meet recon, omitting their achieved times from SWIMS.

### PROPOSED PROCEDURES

- 1. Perform pre-meet recon
- For unregistered athletes appearing on the first pre-meet recon, the MW athlete registration fee is an additional \$30 above the current MW athlete registration fee.

For example, the MW athlete registration fee for 2021 will be \$72. The entering club must then pay \$102 to register each unregistered athlete prior to the entered competition.

- 3. Notify host club meet director, meet referee and admin official that all unregistered athletes, regardless of LSC, who are listed on the final recon error report must be individually addressed by one of the following steps:
  - Not eligible to compete (athlete may be scratched from competition at the discretion of the meet director)
  - Deck registration for which MW procedures are outlined in the P&P Manual
  - c. Provide current athlete membership status via athlete's Deck Pass Plus account, a club roster report from the entering club's portal, or verification of membership by the MW Executive Secretary or MW Registration Chair Rationale: If proof of membership is not provided and deck registration does not occur, the athlete is barred from competing. This is the meet host's responsibility to monitor and prevent such swims from occurring.
- 4. Increase the post-meet recon fine notice to each entering club to \$250.00/athlete from the current \$100.00 fine.

Rationale: This amount has never changed from inception of this policy.

Achieved times for all unregistered athletes in MW competition will **NOT** be entered into SWIMS
