- Financials

  - Finance Update – Betty
    - Noted summer expenses and few meets and less income
    - For now good
    - Question from Patrick R regarding what MW's athlete support looks like compared to other LSCs; Betty noted probably comparable or more, depending on size of LSC
- Sanction Update - Betty
  - Status of summer meets and fall & winter bids in Betty's report
  - Question regarding 800 free relay for Long Course – to shorten meet
    - Several opinions – will take suggestions back to Sanction Committee
  - Question regarding adding 'free' 50s for 12 & U if qualified for one event (like 13 & O)
    - Noted length of afternoon session
    - Noted scoring of B relays allows for kids to participate and score for team
  - Question regarding short course championship survey
    - Emma has shared with sanction committee
    - Sanction Committee will review and share with clubs
  - Kim B questioned date of LC meet on top of Futures
    - Other dates were looked at – Woods not available
    - Noted that LSC summer schedule has to work around national meet schedule – and nothing seems to satisfy everyone – clubs need to make decision as to where to put their athletes
    - Tommy P noted that Futures on top of MW LC Championships is annoying
  - Betsy noted that MW is one of the very few LSCs that does not split championships into Senior and 14 & U
  - Heather Farris - need schedule two years out for planning purposes
    - Noted that Sioux City has 3 50 meter pools – might offer some flexibility
  - Perhaps MW could do LC at Fremont or UNO in May to get in more LC meets in a very short LC season
  - Noted that USA Swimming has not published the 2023 summer meets yet
  - Might need a questionnaire to determine what LSC wants
